Only gas fire pits are allowed. No wood or charcoal fire pits. Fire pits must have architectural approval prior to install.

Both barbeque grills and fire pits must be attended at all times while operating.


### **DROUGHT**

#### **FENCES**

Pease check your fences. If you have cracked or broken pickets, missing pickets, peeling or warped pickets, gates in need of repair, or stain please make repairs and stain as soon as possible.

The fences must be stained properly on the outside. The approved stain color is CABOT Dune Gray—solid stain, available at Lowe's or Ace Hardware.

Please remember that privacy fences must have batten boards, and pickets (see diagram below; also found on the website under the "ACC" tab and "policies"-"fence types.")

# **Architectural Requests**

Before submitting architectural requests, please review the policy corresponding with your project. The policies are located on the website www.rockcreekhoa.com under the "ACC" tab and "Policies."

Plot Plans (obtained from the Town) with the project drawn to scale with dimensions are required for most projects.
